

**CITY OF KRUGERVILLE, TEXAS
RESOLUTION 21-0128-A**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS, ORDERING A GENERAL ELECTION TO BE HELD ON MAY 1, 2021, FOR THE PURPOSE OF ELECTING THREE COUNCILMEMBERS PLACES 1, 3, AND 5, FOR TWO-YEAR TERMS EACH; PROVIDING FOR A JOINT SERVICES CONTRACT WITH DENTON COUNTY TO CONDUCT THE ELECTION; PROVIDING FOR THE POSTING AND PUBLICATION OF NOTICE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Krugerville, Texas, is a Type “A” General Law Municipality located in Denton County, Texas, created in accordance with the provisions of the Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, Title 2A, Section 22.003 of the Local Government Code provides that an election for officers of a Type “A” General Law Municipality shall be held annually on an authorized uniform election day; and

WHEREAS, Section 41.001 of the Texas Election Code, as amended by the 86TH Texas Legislature, establishes the first Saturday of May, 2021, as a Uniform Election Day for the purposes of conducting a General Election; and

WHEREAS, Section 3.004b of the Texas Election Code provides that the governing body of a municipality shall be the authority to order a General Election for electing Municipal Officers; and

WHEREAS, in accordance with Section 271.002 of the Texas Election Code, the City General Election will be conducted jointly with other political subdivisions of Denton County, Texas.

NOW, THEREFORE, BE IT ORDERED AND RESOLVED BY THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS, THAT:

SECTION 1

The City Council of the City of Krugerville hereby orders that a General Election be held on May 1, 2021, being the first Saturday in May of 2021, for the purposes of electing three Councilmembers Places 1, 3, 5, for two-year terms each.

SECTION 2

The election precincts for said election shall be the regular precincts of Denton County (Precincts 1045 and 1006) to the extent that they are within the corporate limits of the City of Krugerville.

SECTION 3

The election will be conducted jointly with other political subdivisions in Denton County on May 1, 2021, pursuant to Chapters 31 and 271, Texas Election Code. The City Secretary is hereby authorized to sign the contract with the Denton County Elections Administrator for the purpose of having Denton County furnish all or any portion of the election services and equipment needed to conduct the election.

SECTION 4

- (a) In accordance with Sections 31.097 and 271.006 of the Texas Election Code, the following named person is hereby appointed as the Early Voting Clerk of the purposes of conducting said election:

- (b) Any permanent county employee serving under the Elections Administrator shall serve as deputy early voting clerks.

SECTION 5

Early Voting by personal appearance for Krugerville residents shall be conducted beginning April 19, 2021 and continuing through April 27, 2021. Dates and hours for early voting shall be as specified by the Denton County Elections Administrator and future notice(s) for the election and incorporated herein by reference, to include at least eight hours of each weekday of the early voting period that is not a legal state holiday, and during other times as specified by written order of the Early Voting Clerk for Saturdays or Sundays within the early voting period. The main early voting location shall be located at:

Denton County Elections, 701 Kimberly Drive, Denton 76208

Additional early voting locations will be identified in the contract executed with the Denton County Elections Administrator.

SECTION 6

The polling place for all of Precincts 1045 and 1006 within the corporate limits of the City of Krugerville will be located at a location determined by the Denton County Elections Administrator to be identified in the joint services agreement.

SECTION 7

The City Secretary is hereby authorized and directed to file, publish and/or post, in the time and manner prescribed by law, all notices required to be so filed, published and/or posted in connection with the conduct of this election. Notice shall be published on the City's website and in the official newspaper of the City, being a newspaper of general circulation within the City, at least once not earlier than the 30th day nor later than the 10th day before election day, as provided in Section 4.003(a)(1) of the Texas Election Code. Public notice shall be provided by posting on the bulletin board used for posting notices


of the City Council meetings not later than the 21st day before election day and filed with the City Secretary. A copy of the published notice that contains the name of the newspaper and the date of publication shall be retained as a record of such notice, and the person posting the notice shall make a record at the time of posting stating the date and place of posting in accordance with Texas Election Code 4.005.

SECTION 8

The election shall be conducted pursuant to the election laws of the State of Texas.
