

**CITY OF KRUGERVILLE, TEXAS  
ORDINANCE NO. 2021-015**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS, AMENDING ORDINANCE NO. 2020-010 (PROVIDING FOR THE FISCAL YEAR 2020-21 BUDGET), AMENDING AND CHANGING SAID BUDGET; PROVIDING FOR SAVINGS, SEVERABILITY, AND REPEALING CLAUSES; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR THE PUBLICATION OF THE CAPTION HEREOF.**

**WHEREAS**, on September 17, 2020, the City Council adopted the FY20-21 Budget detailing a plan of service with projected income and expenses;

**WHEREAS**, on February 25, 2021, and May 12, 2021, the City Council executed amendments of the FY20-21 Budget; and

**WHEREAS**, since May 12, 2021, income and expenses have deviated from projections in the Economic Development Corporation, as attached hereto in Exhibit A;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS, THAT:**

**Section 1.** The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

**Section 2.** The budget attached hereto as Exhibit A and incorporated herein for all purposes is adopted for the fiscal year beginning October 1, 2020, and ending September 30, 2021, and there is hereby appropriated from the funds indicated and for such purposes, respectively, such sums of money for projects, operations, activities, purchases, and other expenditures as provided in the attached budgets.

**Section 3.** That the City Council reserves the authority to transfer appropriations set forth in the budget from one account or activity to another within any individual activity of the City and to transfer appropriations from designated activities or departments to another individual department or activity, for FY20-21, by replacing the information regarding said fund(s) or item(s) with the information relating to said fund(s) or item(s) as set forth in the attached Exhibit A, incorporated herein for all purposes.

**Section 4.** Upon adoption and execution of this ordinance, the City Secretary is directed to attach same and its exhibits to the original City of Krugerville 2020-21 fiscal year budget in all places where said budget is filed as of public record or posted for public inspection.


**Section 5.** If any provision of this ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this ordinance would have been enacted without such invalid provision.

**Section 6.** It is officially found, determined, and declared that the meeting at which this ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.

**Section 7.** That this Ordinance shall be in full force and effect from and after its date of passage in accordance with the law.
